EXPIRY DATES PRINTED ON PACKS

We would like to draw your attention to an issue that is not directly related to FiMVS but does nevertheless affect some users of the system and the patients/consumers. The issue is expiry dates: how they are uploaded in FiMVS, encoded in the 2D data matrices, and printed in human readable format on the packs. As a rule, the expiry date uploaded in FiMVS should be identical to the expiry date encoded in the 2D data matrix AND the expiry date printed in human readable format on packs.
